We may collect and process the following categories of personal data:

- Account data (if applicable): login details, preferences
- Transaction data (if applicable): order details, billing/shipping address
- Technical data: IP address, browser type, device information
- Usage data: pages visited, time spent on the Website
- Marketing data: communication preferences

We do not intentionally collect sensitive personal data without explicit consent.

3. How We Collect Data

We collect personal data through:

- Direct interactions (forms, email, account registration)
- Automated technologies (cookies, analytics tools)
- Third parties (e.g., payment providers, analytics services)

4. Legal Bases for Processing

We process your personal data based on:

- Consent
- Contractual necessity
- Legal obligation
- Legitimate interests (e.g., improving our Website, security)

5. How We Use Your Data

We use your data to:

- Provide and maintain the Website
- Process orders and deliver services
- Respond to inquiries
- Send marketing communications (only with consent)
- Improve performance and user experience
- Comply with legal obligations

6. Cookies and Tracking

We use cookies and similar technologies:

- Essential cookies (required)
- Analytics cookies
- Marketing cookies (only with consent)

You can manage your preferences via our cookie banner.

7. Sharing of Data

We may share your data with:

- Service providers (hosting, payments, email)
- Analytics providers
- Authorities (if legally required)

All parties process data in accordance with GDPR.

8. International Transfers

Where data is transferred outside the EEA, we ensure appropriate safeguards such as Standard Contractual Clauses (SCCs).

9. Data Retention

We retain personal data only as long as necessary, unless required otherwise by law.

10. Your Rights

You have the right to:

- Access your data
- Correct inaccuracies
- Request deletion
- Restrict or object to processing
- Data portability
- Withdraw consent

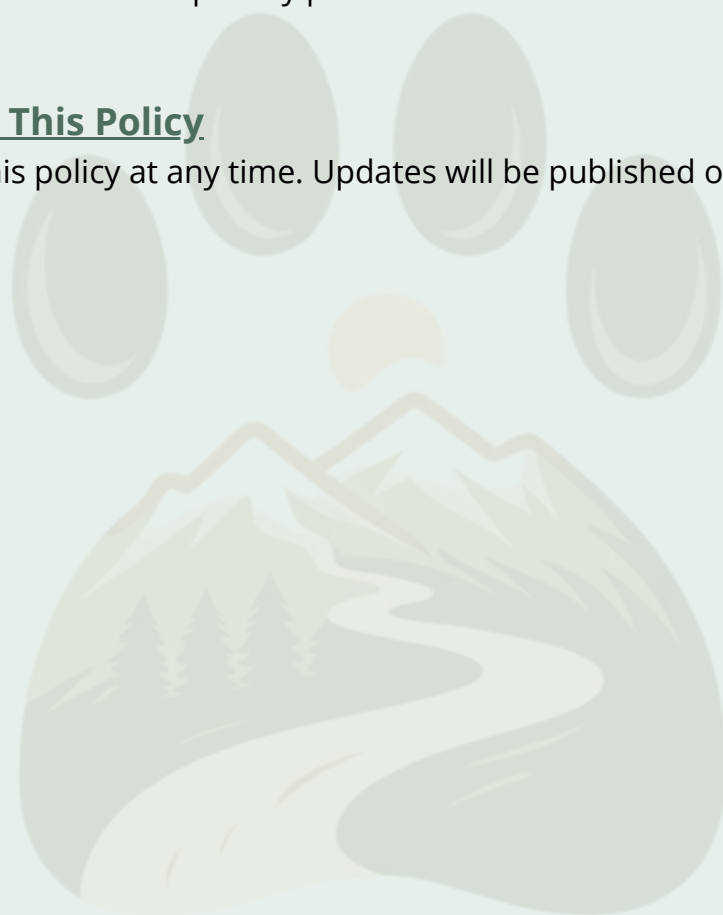
